

Board Meeting Minutes September 2nd, 2025

Reports:

President – Robin Burket opened the meeting with a Newsletter update saying she is gathering the last pieces of the puzzle for Emily and they are hoping for an article on Brian for this issue or next.

Secretary – Cindy Patz asked if there were any amendments to the minutes as sent and corrections were made to the spelling of two prospective members. Christine McDaniel made a motion to approve the minutes as amended, Julie Wangelin seconded the motion, and the minutes were approved as amended.

Treasurer – Robin Bowen reported that we are still waiting on finalization from Citrus County to close the July Specialty and asked if there were any questions regarding the financials as sent via email prior to the meeting.

Committee Reports:

Brian Parker suggested we can learn how to do it rather than wait for the GRCA connection to run it and Julie Wangelin (who ran our

last spin to win) suggested we go to the wheel of names website. Robin Burket said she will coordinate with Amanda Fell.
