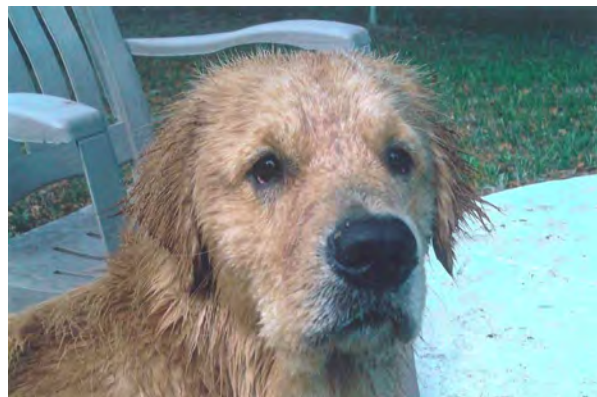

## ***\*GOLDEN RETRIEVER FOUNDATION PAYS FOR SENIOR CERFS!\****

### **\*March 2011 GRF Updates\***

The Golden Retriever Foundation (GRF) is very excited to announce that plans have been finalized to pay for CERF registrations for Golden Retrievers 8 years and older!

CERF, as most of you know, stands for Canine Eye Registration Foundation. We are very fortunate to have an online database via CERF and the Orthopedic Foundation for Animals (OFA) to research health issues in our dogs as well as their ancestors. The GRF will pay for CERF registrations for any Golden 8 years and older to be added to these online registries.

With the designation of Pigmentary Uveitis (PU) as a very serious hereditary disorder in Golden Retrievers about a decade ago and the realization that most dogs with this serious condition will not present with the disease until after many are no longer being bred, the newest recommendation is now to check dogs annually for life. Because the average age of onset for PU is 8 years old, the new recommendation, from GRCA's Health & Genetics Committee, is that all Golden Retrievers that have been used in a breeding

program have their eyes checked and registered for their lifetime with CERF. It used to be common practice to only clear dogs' eyes that were being used for breeding so most were no longer being checked when the disease normally expresses. Additionally, many people never sent the form into CERF for the online database at all.

To assist Golden breeders in making informed breeding decisions, the recommendation is to permanently register these results in a public forum such as CERF. Then breeders can research pedigrees to make more informed breeding decisions in a factual manner even if the owners are no longer able to be contacted. CERF shares results with OFA so the information is recorded there as well. We also want people to know that any eye (or heart) failure can be sent in to OFA and listed for free.

Realizing this recommendation is now asking owners to register dogs that were often not even being checked, much less registered, the GRF decided to pursue helping out with the dogs who have traditionally been least likely to be checked but are most at risk of having PU due to age. Additionally, since Pigmentary Uveitis is such a serious disease leading to pain and often glaucoma and/or removal of the eyes if not caught early and treated, we also want to encourage everyone with older dogs to get them checked even if they have never been used in a breeding program. Paying for the registration is our way to encourage and support this effort.

The program involves printing out a simple voucher to be included with the CERF form you send in for registration in the database. It is understood that all dogs will be included in the public database so the owner must agree to results being published. We encourage everyone to share the information about the voucher with all Golden owners. If your club is holding a health clinic, please print some of these vouchers to have on hand as well. The voucher will soon be available on both the GRCA and GRF websites but you can get a copy now by going to the following link:

Let's all work together to help reduce the occurrence of this painful eye disease.

I want to thank everyone for allowing me the privilege to work as your Puppy Referral Representative. Puppy Referral is like a 'Welcome Mat' to all that our club has to offer to prospective new members (puppy buyers). It allows us the opportunity to meet and educate the public while assisting in placing quality, healthy puppies into new homes.

Puppy Referral is a **tool** to help you, as a breeder, find good homes. There are no guarantees that the public will choose to buy a puppy from you simply because you list a litter on our club's website. In other words, it is not the club's responsibility to place a breeder's puppies. There have been questions recently regarding the way litters are listed, the length of time a litter is listed, etc. I would like to clear up a couple of those questions.

#1) When people call me I **DO NOT** send them to a particular breeder or listing. Instead, I refer them to the website so that they can obtain the information for all of the litters listed at the time. If I have new litter information not yet up on the website, I will give that information to them as well.

#2) Our webmaster places the listings as they come in. They are not listed in any particular order (i.e., date of birth, alphabetically, location, etc) Most puppy buyers look for puppies 'closest to home' first; how they are listed is of little importance.

#3) The club has set a listing time limit of four months from date of birth. However, if a litter has been previously listed, a breeder has a puppy returned for any reason, that puppy is put back on referral at no charge. It may appear that the 'litter' has been listed for an extended period of time.

Over the past several months it became very clear that we needed to address some issues concerning the Puppy Referral program. As a result, our board has decided to make the following listing requirements:

**New Puppy Referral Requirements  
for  
Mid-Florida Golden Retriever Club**

- Must be a regular member in good standing during the previous 12 months
- Puppy referral listing will be limited to 4 months after litter whelp date
- Fee Schedule:
  - If member has attended 2 general club meetings and worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$25.00\*
  - If member has not attended 2 general club meetings and has not worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$250.00

\*It is the responsibility of the club member to notify the club secretary and the event chairperson to receive credit for these requirements.

# MEET THE MEMBERS

**Editors note:** Joyce Swegle is a long time member of MFGRC and is very active in obedience, agility and tracking. We think you will enjoy getting to know her if you haven't had that privilege yet. Thank you Joyce for agreeing to talk with us this month!

**How did you get involved with goldens?** I grew up with dogs, and showed German Shepherds in breed, JS, and obedience. The first CD I ever earned was on Brix, my GSD. Unfortunately, he developed hip dysplasia, and had to be retired. My late husband actually picked Goldens. Brix didn't want to share, and had to live with my parents after I married. I wanted a dog, so at the Ft. Lauderdale all breed club show, Dennis pointed out a golden. Our first Golden, Enoch, developed hip dysplasia, was undershot, oversized (too tall), monorchid and had seizures. We moved to the Orlando area in 1979. I showed our second Golden in breed, put 5 points on him, and then had to quit due to family life, kids, etc. In the early '90s, with more time on my hands, I came back to obedience. Tyler didn't work out in breed, but loved obedience, and earned his CDX. Turner was next, and he earned his Championship, his/our first UD, and with the help of Susan Fulenwider and Ann Rowe, he also earned his WC. Garrett, earned our first UDX and was our first foray into agility and took lots of Rally titles. Dylan, the joy of my life, my heart dog, earned his OTCH, his UDX 4, his GRCA Obedience Hall of Fame, and his RE (Rally Excellent). He was nationally ranked in Rally after only a few months of showing in it. He was also learning to track. They are all at the Bridge now.

**What or who got you interested in Tracking?** Because I was interested in obedience with Brix, I read everything I could get on dogs. I still have some of those real old training books by Winifred Strickland and Blanche Saunders. Way back when, tracking was a part of utility. In 2004 the Daytona Obedience Club held a tracking seminar with Diane and Dutch Schultz. That did it! I took Ziggy (who was a puppy) and he just seemed to really enjoy it. We started to train, took lessons, and I loved watching how quickly puppies can pick it up.

**Explain how tracking works, and what the titles mean.** In tracking, a human scent is laid (just by a track layer walking), left to age a bit, and then the dog (hopefully!) follows the exact pathway to the glove which is left at the end of the track. The day before an actual test, the 2 judges plot the actual tracks, and flag the start, the turns, and the end. The track layer follows, and prepares their own map to follow the next day, in case the dog makes a mistake and loses the track. That way the track layer can help the dog find it. On the day of the test, the track layer walks the track again, and leaves the first 2 flags BUT picks up the remaining flags, and drops the leather glove at the end. The track is left to age while the draw is held. Each entrant draws the track they will ultimately run. Each track is at least 440 yards long, with 3 to 5 turns, and has aged 30 minutes to 2 hours. The dog follows the scent of the track layer to the glove. The team that makes this has earned their TD - Tracking Dog title. The TD test is what we will be offering on May 1. After the dog has earned the TD, they may go onto to either the TDX (Tracking Dog Excellent) or the VST (Variable Surface Tracking). The dog that earns each of these is deemed a CT or Champion Tracker. The TDX is much more difficult for the team. It is 800 to 1000 yards long, is aged 3 to 5 hours, has 5 to 7 direction changes, has human "cross tracks", and obstacles like ditches or woods. A VST is also 3 to 5 hours old, but goes across roads, sidewalks, around buildings, etc.

**How would you encourage someone to get started in Tracking?** Find someone with a like interest to train with. You can do it yourself, but it's more fun to train with friends. I either train alone or go out with some friends. We help each other out, when we have the time. You have to be motivated, as it's hot and time consuming. But it's an incredible feeling watching the dogs track, and even more so, when you start a puppy and then watch them grow into it.

**Tell us about your dogs and their accomplishments.** I have 4 dogs now, and they all have their TDs. Ziggy was our first TD, he hates showing in obedience but loves training in it - except for stays. He loves agility. He has his RE, TD, AXP, OJP, OFP. Henry is Ziggy's half brother. He has his UD, RE, TD, is doing some field work, and some agility, but we are still working mainly in obedience. Micah, has earned his VCD1 (CD, NAP, NJP, TD) and his RN and NFP. A few weekends ago, he earned his OJP. Hopefully this summer will work on his CDX. We are also training TDX work. Alexander has earned his TD (first time out at 13 months), his BN (Beginners Novice) and RN. He is training mostly in obedience and tracking, (VST), with some agility thrown in.

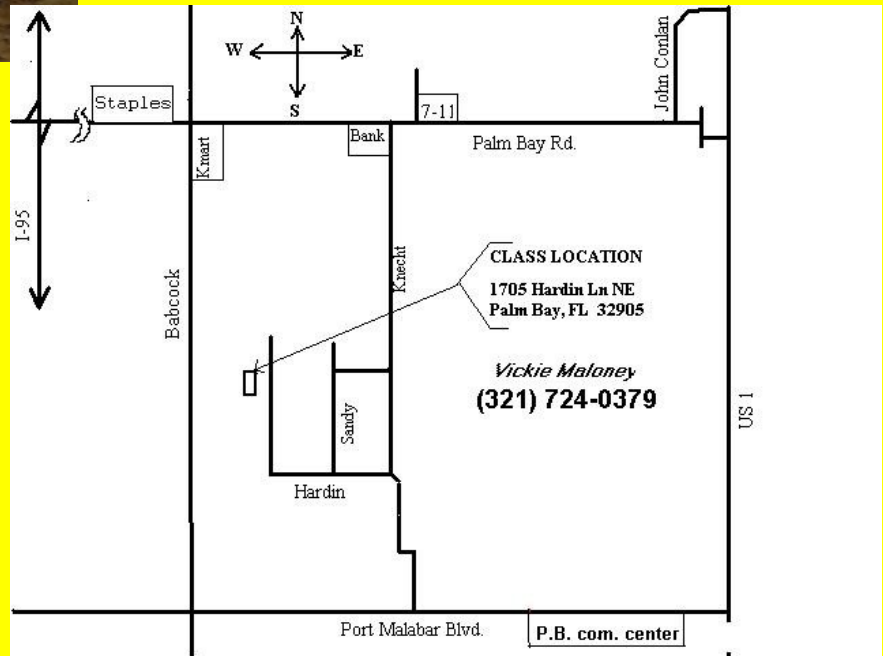
