We had a full test this year and, with entries being down in every venue throughout the country, this is a big accomplishment.

The next weekend was our very successful spring hunt test. I know Mike will give a full report, but I just wanted to make a couple of comments. We had over 300 entries, our biggest ever, which necessitated the addition of a third Master flight. AKC only allows 60 dogs per flight and on closing day we were just 9 dogs short of adding a fourth flight. Mike had arranged to have another set of judges in the wings "just in case", so that was taken care of. The real panic set in when we realized we needed many, many more birds. Ducks are becoming extremely difficult to find at a reasonable price and with so many of our old suppliers leaving the business it was a huge scramble to find the additional ducks. As always, Tom Hell came through for us and accomplished this seemingly insurmountable task.

I've been to nearly every hunt test that MFGRC has hosted and I can honestly say that this was one of the most organized and efficiently run tests we have had. The success of this hunt test was, in no small part, due to the efforts of Mike Orloff, Tom & Joanne Hell, and Wayne Guy. Every time something needed to be done they were there getting it done. We are so lucky to have Wayne and Sharon Gey as part of the MFGRC family. They not only welcome us to their land, open the doors of their home to everyone at the test, but they work tirelessly to help in our success. Our Spring Hunt Test is dedicated to the memory of Susan Fulenwider who worked so hard to bring this event to us every year. I know she is proud of the efforts put forth by so many to make this one of our best tests. We could have used Susan's "weather witch" abilities though. It was really, really cold for two legged participants but the dogs said it was perfect hunt test weather.

The last and final event of the month was our "sort of" annual eye and heart clinic. These clinics have always been important to me so this year's success is very rewarding. We saw more dogs in both the eye and heart clinic then we've seen in the past. We have been doing these clinics now since the early 1990's and I hope we will continue to have the support of the veterinary specialists and the members of our club. Thanks to Dr. Noelle McNabb and Dr. Wendy Arsenault for being a part of the clinic. They are both very interested in participating again next year. Thanks also to the club members who came out to help. Laura Topping, Judi Volpi, Leah Wright, Mary Coffman, Debbie Caudill, Nanette Tschigri, Candi Pearce, Cindi Metcalf, and Kathy Cudak. The clinics ran so well because of your help.

Mark your calendars. Saturday, March 24 is our annual match held at the Rowe's home in Sorrento. Look for the premium list in this newsletter and on our web page. Please note, the date of closing has been extended to March 21, 2012. Remember, each entry requires a donation to the raffle.

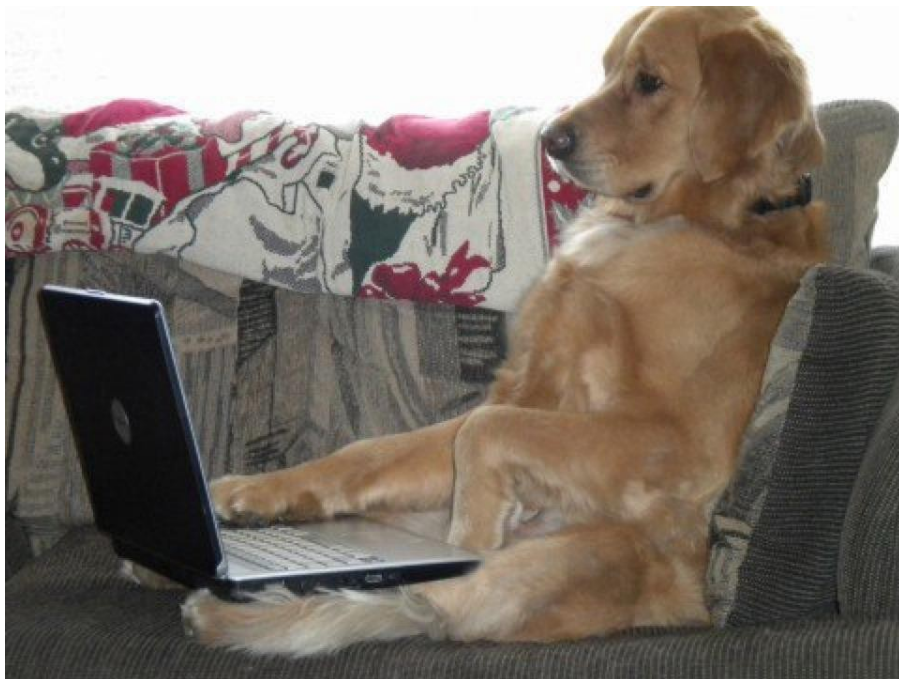

I want to thank everyone for allowing me the privilege to work as your Puppy Referral Representative. Puppy Referral is like a 'Welcome Mat' to all that our club has to offer to prospective new members (puppy buyers). It allows us the opportunity to meet and educate the public while assisting in placing quality, healthy puppies into new homes.

Puppy Referral is a **tool** to help you, as a breeder, find good homes. There are no guarantees that the public will choose to buy a puppy from you simply because you list a litter on our club's website. In other words, it is not the club's responsibility to place a breeder's puppies. There have been questions recently regarding the way litters are listed, the length of time a litter is listed, etc. I would like to clear up a couple of those questions.

#1) When people call me I **DO NOT** send them to a particular breeder or listing. Instead, I refer them to the website so that they can obtain the information for all of the litters listed at the time. If I have new litter information not yet up on the website, I will give that information to them as well.

#2) Our webmaster places the listings as they come in. They are not listed in any particular order (i.e., date of birth, alphabetically, location, etc) Most puppy buyers look for puppies 'closest to home' first; how they are listed is of little importance.

#3) The club has set a listing time limit of four months from date of birth. However, if a litter has been previously listed, a breeder has a puppy returned for any reason, that puppy is put back on referral at no charge. It may appear that the 'litter' has been listed for an extended period of time.

Over the past several months it became very clear that we needed to address some issues concerning the Puppy Referral program. As a result, our board has decided to make the following listing requirements:

New Puppy Referral Requirements for Mid-Florida Golden Retriever Club

- Must be a regular member in good standing during the previous 12 months
- Puppy referral listing will be limited to 4 months after litter whelp date
- Fee Schedule:
 - If member has attended 2 general club meetings and worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$25.00*
 - If member has not attended 2 general club meetings and has not worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$250.00

*It is the responsibility of the club member to notify the club secretary and the event chairperson to receive credit for these requirements.

Memorial to Diane Maria Makinney

Sept. 20, 1953-Jan. 23, 2012

Shortly after Diane died, a dear friend emailed me a set of pictures. As I ran through the list, I found myself totally absorbed in one particular scene. It was of an exquisite gushing mountain waterfall plunging through a lush expanse of greenery into a mirror-like crystal clear lake below. We have all seen such falls, some tumultuous, some lacy, some trickling. Always it is riveting. A giant river is born of melting winter snows, converging streams, and spring rains. The sources seek and find each other to create new and bigger waterways never knowing where they will go next, but gaining the power to forge ahead with each overlap.

It occurred to me that life is exactly like that photograph. We are born an empty slate and must begin to write on that slate immediately. Like the river, we move through life learning, gaining skills, wisdom, meeting challenges, getting a bit murky at times, but learning from the experiences how to approach life's next choice. We laugh as a bubbling brook and drop tears in time of strife, only to pour our efforts, new-found wisdom and talents into life's next pool of opportunities.

Diane was born in Chicago when I was ten years old. She began writing on *her* slate as a child in the Windy City. There were visits to our farm in Indiana where she was first exposed to the loving licks and loyal friendship of our dogs—gentle, bright standard collies. Some years later, Christmas brought her a black poodle which she named Noel. As an adult, in Florida, she fell in love with a very mischievous red golden retriever—Attila the Honey. We all know what a giant whitewater river that relationship created! There were obedience classes, dog show interests, more goldens, educating herself and others on dog issues.

She joined Patti Strand's National Animal Interest Alliance (NAIA) to combat inappropriate regulations on animal ownership. She drew from her previously developed Bell South and Mathis Group research and public relations roots. This time those skills were driven by her personal love of animals as she focused her analysis on legislative matters, public education for animal ownership and care, and the rights and responsibilities of individuals to own and care for their own pets. That work, Honey, Sampson, Tanner, and her foster dog Dixie drew her more and more into organizations such as the Golden Retriever Club of America and the Golden Retriever Rescue of Mid-Florida and an adviser to the American Kennel Club. Her pool was now a sea of national and sometimes international dimensions. Newsletters were created and websites supported.

Because of her legislative interests, research skills, and cherished values Diane's next passionate plunge was into her nation's recovery on the liberty and economic fronts. She carefully studied the Ron Paul Revolution and took on-line classes in history and economics at the famous Mises Institute. Her legislative talents grew even more as she set foot into that stream, contacting and supporting or contradicting candidates, U.S. congressmen and senators. Again she joined with more people to learn and prod beyond her previous shores.

Diane's most recent leap forward and joy were accomplished in the past year with the guidance of her close friend of three decades. Kathy Rahla, a devout master gardener, and Diane studied, designed, and created a garden plan for her Beaumont home. It was to provide organic nourishment for the table, healthy exercise through planting, sunshine, and a display of beauty for all to enjoy. The two drove miles to find just the right seeds, plants, and ideas. She placed a Florida holly tree in the ground only days before she left us. Friends and neighbors have already dubbed that her memorial plant, as it was her favorite addition to the yard! Diane was ecstatic as they drove hither and yon in their pursuit of just the right sizes, shapes, colors, and attributes to realize the plan that lay in her mind's eye! There was enough passion in both their hearts to accomplish their ever growing task and Diane took great pleasure in walking friends through the healthy young greens.

In her final hours Diane was last seen watering her new gathering of green beauties. Life was flowing into the world as Diane was saying her good bye. My hope is that our time celebrating Diane today will give a larger view of the exquisite life stream she brought to each of us and that we, in turn, will keep the waters flowing!

MFGRC TD/TDX

The MFGRC combined TD/TDX Test was held on February 5th, 2012. This year, for the first time, we offered a combined Tracking Dog test and a Tracking Dog Excellent test. We allowed for four TD tracks and three TDX tracks. We did get one TDX entrant, and eight TD dogs and one alternate. Our judges were Ron and Luci Seeley. Our track layers were Judi Volpe, Betty Lambert, Debbie Finch, Jodie Faist, Paul Reep and Ron Pagano.

Sunday morning dawned with very dense fog. As it cleared over Orlando, it seemed to settle into the tracking fields. This caused the tracks to go in later than usual, and set back when the dogs could actually get onto their tracks. You could tell that some of the exhibitors were getting antsy! We finally got the call that we could head to the fields, and we started to roll.

I won't go into all of the tracks, and what happened on each one, but having walked several of them the day before, I can honestly say that they were all lovely tracks. And the TDX track was awesome. We had two out of state exhibitors. The TDX dog came from Indiana, and two TD dogs were from the West Chicago area. Unfortunately, these dogs didn't find the elusive glove, but they both enjoyed the test, and the Chicagoan remarked how great the fields were, how nice the club was- and that she hopes to come back next year!

We had two passes, way back in the high grasses, and later in the day when it was warmer! Go figure! Labrador Retriever, Shenandoahs Runway on the Hudson (Sully), owned and bred by club member Janet Narushka, Janice Fitzgerald, and Andrew Gibbons, was our first pass of the day. Sully, literally ran the track. And then Nova Scotia Duck Tolling Retriever Redstarr's Jenuine First Class Act CDX,RE,NA,NAJ, owned by Terri Bell, also rapidly made her way to the glove, earning her TD. This TD also earned her the VCD1 and she is only the second of her breed to do so. Watching these two dogs track, was just incredible.

Thanks to our judges, Luci and Ron. The tracks were just wonderful! Thank you to our track layers, and to the committee members, who all gave of their time to support tracking. Two of our track layers are not even club members, but were willing to give up two days to help us out! Thanks so much Paul and Ron!

I would like to just give our members some background info on the fields we use. They are all owned by the Lee family, who generously, allows us use them for our tests. I met "Joe" this year, who grew up on the fields, manages them today, and who filled me in on their past uses. The front end of the fields were used by grazing cattle, and the back end of the fields we use (closest to the airport runways) were corn fields. Thanks to the Lee family, and Joe for the use of, and care of, the fields.

We are so lucky to have Wayne and Sharon Gey who open their ranch and home to us to make the tests possible, and who also work so hard to make our events a success. Sharon did her usual fantastic job catering the judges' dinner, ribs and all the fixins' Friday night, and they also hosted our tailgate party Saturday night. And Wayne was everywhere all weekend. He spent all day Friday digging a giant hole and using the clay to grade the roads to make them passable, and all weekend when the marshals would call for help moving a stake to its next series, by the time one of us mere mortals could get there, we would be met with "Oh, Wayne was already here and took care of it." The Geys also supplied enough grandkids to staff Master B with bird technicians.

The setup crew arrived early Friday – followed by the judges. The test sites were assigned and the tests set up. As usual, Tom and Joanne Hell worked tirelessly – arriving long before everyone else, moving the trailers and pulling out all the equipment assisted by Ray and Carol Caito. John Blair left a sick Rosa home with a new litter of puppies to help with the setup.

Speaking of changes – thanks also to Judi Volpe who had her hands full as Test Secretary (and fill in bitch checker). She dealt with all the changes and scratches without complaint and then did a fantastic job posting all the results.

Boy Scout troop 599 from Deland worked hard all weekend smoothly and efficiently staffing all the stakes except the one Wayne's family took care of.

The gunners came from far and wide and did an excellent job. Thanks to Chuck Masters and friends Ed & Richard; John Gerbino & Dana Smith; Alex & Ede (the Hungarians!); and Ray Caito & Jim Bryan. We wouldn't have birds to retrieve without them.

And the lunch makers Shirl Phillips, Debbie Finch, Ann Rowe, Camille Doehring, Joanne Hell and Carol Caito – who worked tirelessly behind the scenes to make sure all the workers and judges were fed. I was running around at various stakes all weekend, and never heard anyone call for lunches – they just magically appeared – at just the right time. The test cannot run if all the workers and judges are not fed (and aired) in such a timely fashion.

And last but not least – the bitter end crew – Ray & Carol, Tom & Joanne, Camille, Judi, Debbie, Wayne, Stephen Rosasco, Jill & Mike Wallace and Leah Wright who stayed until all the equipment was put away, all the birds were sold or otherwise accounted for and everything was cleaned up. We could not have these tests without all you who stay to make sure all the loose ends are tied up (and put away).

I hope I haven't left anyone out – my sincerest apologies if I did and my thanks for all everyone did. I was so busy running around trying to make sure everything was done and everybody was doing all that needed to be done, that much of the weekend was and still is a blur. Except, of course, for little Ozzy's first Master pass in his First Master test – thanks Mid-Florida GRC and Bear and Sam!!!

All I can say is – it was a hell of an experience – it makes chairing agility trials seem like child's play. It was also a huge learning experience. Special thanks go to Tom Hell, who while no longer the official chairman, worked tirelessly to advise me about what I had to do, and make sure everything got done properly. Hopefully next year, I can do more on my own, and not have to impose on him so much. And thanks to Joanne for being there with him every step of the way.

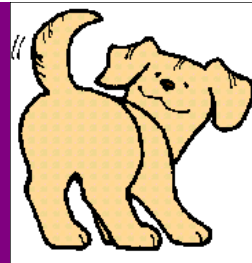
