DECEMBER BOARD MEETING MINUTES

The MFGRC Board Meeting was called to order by President Debbie Finch at 7:53 P.M. on December 4, 2009 at the home of Camille Doehring in Orlando.

Board Members Present: Debbie Finch, Camille Doehring, John Blair, Rosa Blair, Judi Volpe, Tom Hell, Joanne Hell, Shirl Phillips, Ann Rowe, and Betty Lambert.

Vice President's Report: Shirl Phillips had no new membership applications to read.

Secretary's Report: Betty Lambert related that the minutes from the last Board Meeting have been forwarded to Leah and will be published in the newsletter. Joanne Hell made a motion to waive the reading of the minutes, and Judi Volpe seconded the motion. Betty shared a letter from the GRCA 2010 Nominating Committee. They need several positions filled for next year, and the letter was asking for clubs to encourage their members to consider applying for these open positions. Betty also announced the receipt of an e-mail from the St. Petersburg Dog Fanciers Association. They are having an AKC Sanctioned B Match on Saturday, January 2, 2010 in Largo. Treasurer's Report: In the interest of the Club, we do not publish income information on the Internet. Tom Hell announced that membership dues are now due, and will be delinquent January 1, 2010. There will be reminders published about this in the newsletter.

Committee Reports:

Christmas Party: This will be held at the home of Ann and Bob Rowe in Sorrento next Saturday, and Tom provided Ann with copies of the insurance rider to cover their property. Ann reported that she will need coolers and ice, and reminded everyone that members need to bring homemade side dishes to go along with the turkey and ham.

January General Meeting: We discussed whether or not to try and have a fun field day in January or an agility fun day, since Vickie Maloney & Jackie Hardin have offered the use of their property in Palm Bay for an agility fun day that month. Debbie will follow up with Vickie as to possible dates in January, and will then report back to the Board.

2010 Match: This will be held on Ann Rowe's property also, on March 20, 2010. Joanne Hell reported that she has contacted Matthew Twitty, and he has agreed to be our Obedience judge. We are still working on finding judges for Conformation and Rally.

2010 Specialty: Betty Whaley will be contacting several judges provided by the Judges Selection Committee to see if they are available and interested in judging our Specialty. Trophies were discussed. We would very much like to have Leah and Jon make the picture boxes for the major prizes, but need to come up with other ideas for all of the first place finishers. A few suggestions were made, and Board members will be contacting certain individuals to see if they could make items for us in the \$10.00 price range per item.

Old Business:

There was a lot of discussion about the WC/WCX. Due to the fact that only one Golden passed the WCX, there was discussion about whether or not the Test Committee should have intervened and spoken to the judges about possibly changing the set-up of the test. This will be something that next year's committee members need to be more aware of. A suggestion was made about possibly limiting the entry next year to only Golden Retrievers, Flatcoats, and Labs. However, it was recommended that some research be done as to the specific test requirements for all of the different breeds before making any decision about only allowing certain breeds to enter the test.

There was more discussion about the Heart & Eye Clinics at the Strawberry Cluster next February. Camille has offered to put it all together and get everything set up, but she said that due to her work schedule it is more than likely that she will not be available to be there that weekend. Judi stepped up and said that she can be there both Saturday and Sunday to make sure everything runs smoothly. We will need Club members to volunteer to help out both days, and more information about that will be coming out closer to the Cluster. The dates for the Clinics will be February 20 & 21, 2010.

There was discussion about the end of the year awards. Apparently there is a question about the wording of the requirements for Field Dog of the Year, where it says limit 4 legs. The Board members discussed this in length, and stand by the intent of the requirements when written to mean that the "limit 4 legs" means 4 legs earned towards the title, and not additional legs earned after the title. Ann Rowe made a motion that the "limit 4 legs" requirement only applies to those 4 legs earned towards the title, and not any legs earned after the title. Shirl Phillips seconded the motion. All were in favor. The Board will be reviewing all award requirements with the intent to prevent any further confusion.

New Business:

There was discussion about the possibility of the Club holding an obedience trial in Astatula. There are now two structures on the property with a total of 10,000 sq. feet under roof cover. There would be enough space to set up 2 rings. One structure has an asphalt floor and the other has a dirt floor. The pros and cons of this location were discussed, but no decision was made one way or the other at this time.

The next General Meeting will be held at the Christmas party on Saturday, December 12, 2009, at the home of Ann & Bob Rowe in Sorrento. The next Board Meeting will be held on Friday, January 1, 2010 at the home of John & Rosa Blair in Satellite Beach.



Specialty Breed Judges

Barbara Pepper

I bought my first golden in 1968, and began showing in matches and point shows in the early 1970's. I have breed and finished numerous champions, including National Specialty, Independent Specialty, Group and Best in Show winners. I personally handled one of the first Golden Retriever Bitches to achieve GRCA Show Dog Hall of Fame status (Am. Can. CH. Russo's Pepperhill Poppy). Dogs I have bred were not only successful in the breed ring, but did well for their owners in performance events and in the field with active hunters. I have been judging Golden Retrievers since 1991 and am presently approved to judge Golden Retrievers, Labs, Cavaliers and the Hound Group. I am currently a member of the GRCA Judges Education Committee, a Level 1 CCA Evaluator, and an approved mentor.

Maureen Shaughnessy, D.V.M.

I obtained my first golden retriever in 1979, rescued from the Veterinary Technician program I was attending. He was trained through his CDX but did not title as I was admitted to veterinary school and lost all leisure time for four years.

I obtained my first show puppy in 1987. I finished his championship novice owner handled in 1990. He went on to become Ch Krishna's Eddington of Sabra, CDX, JH, WC, and VC, all owner trained and handled. He has become an outstanding sire and is the basis for my breeding program.

I brought my first show bitch home in 1989. She was championship pointed, Amberac's Mystical Charm, CDX, JH, WC, VC and OD titles and was the dam of my first two homebred champions. My first litter was whelped in 1994, I use Kamaglo as my kennel name. My first champion was born in my first litter, Ch Kamaglo's Premiere Issue, CD, WC, VC, breeder-owner-handled. The second was from my second litter, Ch Kamaglo's Brann MacEddington, JH, CDX, RAE, WC, VC.

I have produced eight champions to date, most of whom are performance titled as well. I have also finished multiple dogs obtained as stud puppies owner-handled.

I decided to judge because I had grown so weary of people who do not judge dogs but point at handlers. I am judging because it is the right thing to do for the breed, it's about the dogs.

Many people think , being from Britain, that I had a background of goldens dating back to that time. Not so. When I purchased my first house here, in 1967, I purchased my first golden – out of the newspaper! I was lucky. 

Richard and Debbie Caudill and their Snobird kids want to wish everyone Happy Holidays, and are starting the new year off with some big brags:


