We are so happy you're here!!!!

I want to thank everyone for allowing me the privilege to work as your Puppy Referral Representative. Puppy Referral is like a 'Welcome Mat' to all that our club has to offer to prospective new members (puppy buyers). It allows us the opportunity to meet and educate the public while assisting in placing quality, healthy puppies into new homes.

Puppy Referral is a **tool** to help you, as a breeder, find good homes. There are no guarantees that the public will choose to buy a puppy from you simply because you list a litter on our club's website. In other words, it is not the club's responsibility to place a breeder's puppies. There have been questions recently regarding the way litters are listed, the length of time a litter is listed, etc. I would like to clear up a couple of those questions.

#1) When people call me I DO NOT send them to a particular breeder or listing. Instead, I refer them to the website so that they can obtain the information for all of the litters listed at the time. If I have new litter information not yet up on the website, I will give that information to them as well.

#2) Our webmaster places the listings as they come in. They are not listed in any particular order (i.e., date of birth, alphabetically, location, etc) Most puppy buyers look for puppies 'closest to home' first; how they are listed is of little importance.

#3) The club has set a listing time limit of four months from date of birth. However, if a litter has been previously listed, a breeder has a puppy returned for any reason, that puppy is put back on referral at no charge. It may appear that the 'litter' has been listed for an extended period of time.

Over the past several months it became very clear that we needed to address some issues concerning the Puppy Referral program. As a result, our board has decided to make the following listing requirements:

New Puppy Referral Requirements for Mid-Florida Golden Retriever Club

- Must be a regular member in good standing during the previous 12 months
- Puppy referral listing will be limited to 4 months after litter whelp date
- Fee Schedule:
 - If member has attended 2 general club meetings and worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$25.00*
 - If member has not attended 2 general club meetings and has not worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$250.00

*It is the responsibility of the club member to notify the club secretary and the event chairperson to receive credit for these requirements.

GPS, Google, Mapquest and other programs are not often helpful for this location. There are also few street signs once you get to the 1 mile of dirt road, so the landmarks listed will help you navigate easily. Bright pink paw prints show up periodically to reassure you that you are headed the right way, and some are angled to help point the way to turns. Please drive slowly once you get to the dirt road to avoid frightening horses and other livestock, as well as local wildlife. We regularly see deer, wild turkeys, bald eagles, hawks and more. Lower speeds also help preserve the road work done so far.

For most coming FROM SEMINOLE etc.: SR417/Greeneway to Lake Mary Blvd. exit FROM SOUTH -

Right on CR427, right on Lake Mary Blvd.; OR take Hwy. 17-92 to CR427 and right/northeast on Lake Mary Blvd.; OR take SR46 to SR415

Lake Mary Blvd. becomes SR415 after you cross over SR46

From the **south**, starting at the intersection of Lake Mary Road/SR415, where it intersects with SR46:

5.4 miles North on Lake Mary Road/SR415 towards Daytona Beach/New Smyrna

Over bridge near Marina

Pass Osteen Diner on right, Dollar General and Sunoco on left

where speed limit slows to 45 mph; slow down for turn --just 2 blocks more

Second **right - Railroad Avenue**

At post office sign, small street, not a major intersection, directly across from Texaco

Immediate first left on New Smyrna Blvd. at feed store

Immediate first right onto Florida Ave/Osteen Maytown Road/ SR4164

SPEED TRAP – 30 mph speed limit till you reach the golf course

5.3 miles to Pell Road; watch for intersection sign on right, after two small bridges.

Slow down as soon as you see sign that says Pell intersection is just ahead because it comes up fast!

Left on Pell Road (Towards Wiregrass Prairie Reserve)

3.9 miles to Saddle Creek Farms Road (Watch for Tractor Crossing Sign)

If paving on Pell Road runs out you have gone too far

Right on Saddle Creek Farms Road White fencing on either side of entrance; Saddle

Creek Farms sign on fencing but no street sign at that intersection

mailboxes by fence, turn BEFORE you pass tractor crossing sign

Now 1 mile and several turns to go on dirt road from Pell to our house. Few street signs once you turn onto the dirt road before you get to the Best Paw homestead.

Left at V in road (left-pointing paw print on pole) to remain on Saddle Creek Farms Road

Road turns sharply at stop sign; **right at Oak View Plantation Road**

Immediate (first) left at Oak Haven Plantation Road

To second home on right

Storage building with green roof in back you can see from the previous turn

Agility equipment out front; dog signs on fence and dog yard art

pole barn with chairs in driveway

FROM NORTH/WEST

West/south on I-4 to SR44, east on SR44; or from Deltona/Orange City take Howland or CR4162 east to SR415

South/right on SR415

From Dirksen/Deltona/CR4162, take third left.

From Howland Blvd. or further north

continue about 1 mile south past Wal Mart (at Howland Blvd. and SR415)

Pass CR 4162 and Skip's Boots on your right

Left/east on New Smyrna Blvd.

third left (first left turn lane) after CR 4162; small street, not a major intersection

Immediate left/east on Florida Ave/Osteen Maytown Road

Then follow directions above from intersection of New Smyrna Blvd./Florida Ave./Osteen

FROM DAYTONA/NEW SMYRNA:

Either SR44 to SR 415

OR

US1 south to Halifax Ave. (flashing traffic signal) in Oak Hill, west/right 17 miles to Pell. Right onto Pell; then follow above directions.

FROM INTERSTATE 95, TRAVELING NORTH FROM SOUTH FLA.:

Take CR-5A exit, Exit 231, toward Oak Hill/Scottsmoor .3 miles; merge onto CR-5A/Stuckway Rd. toward Oak Hill/Scottsmoor 1 mile; Left onto U.S.-1 N/SR5 North 6.9 miles; LEFT onto W HALIFAX AVE/CR-4164. Continue to follow CR-4164, 16.9 miles; right onto Pell Road, then directions above from Pell

Certificate of Conformation Assessment (CCA)

What is a CCA?

A CCA evaluation is a non-competitive area of participation in conformation where golden retrievers are evaluated against the Breed Standard. The owners are given a written assessment of their dog, which provides information not available in the show ring. The CCA tests each individual dog in ten categories on physical conformation and temperament. Three evaluators are used, of which two must be licensed AKC judges and golden retriever breeders, and are chosen because of their experience and background.

The CCA is open to all registered or ILP goldens over 18 months of age, including those dogs which have been spayed or neutered.

In addition, passing the CCA provides one conformation point, which can be used toward the GRCA Versatility titles (VC, VCX).

What are the qualifications for evaluators?

Category I evaluators must be approved AKC or CKC judges in good standing, are Golden breeders and/or have had at least two years of experience in judging Golden Retrievers.

Category II evaluators must be a breeder and owner of Golden Retrievers with ten years experience in Golden Retrievers; has bred at least three Golden Retriever litters; and has owned at least five different Golden Retrievers with any of the following titles: (a) AKC champion; (b) AKC UD or TDX; (c) AKC MH, SH; (d) AKC AX or AXJ.

All evaluators must have an understanding of retrievers and sporting dogs, including the purpose and function of the Golden Retriever. Evaluators must also be familiar with the process of evaluating dogs against the breed standard, rather than simply comparing dogs to each other. Evaluators must also be willing to give a written opinion on each dog.

For more information, see the attached “Frequently Asked Questions”. Additional details on the CCA are also available on the GRCA website at www.GRCA.org.

Certificate of Conformation Assessment (CCA) FAQ's

1) What is the original intent of the CCA?

Twofold: (a) to provide a NON-COMPETITIVE area of participation in conformation where dogs are assessed against the Breed Standard rather than merely against other dogs present and (b) to give owners written reports as to the evaluators' assessments which will provide information not available in the show ring.

2) How does the CCA compare to other basic non-competitive, entry level tests offered to Golden Retrievers?

Both the Hunt Test and WC programs require an average passing score of 7 points in all categories and the number of attempts is not limited.

The CCA program is also on a point scale requiring the dog to score a minimum of 75 or higher out of 100 possible points, broken down into ten categories. A non-competitive CCA event tests the individual dog on the physical conformation and temperament qualities as set forth in the Breed Standard. There is a limit on the number of attempts that can be made. It also has a mandatory pass for temperament and sets a minimum age of 18 months. While the conformation quality of a retriever MAY improve with maturity and conditioning, the basic structure changes very little.

The CCA, WC, and Hunting Test programs are similar in that they all reward very good to excellent representatives of the breed by comparison to an impartial criteria without bias or dog-to-dog competition, and they all test the desired physical and/or mental attributes of a sound hunting companion.

3) Why have a seemingly high percentage of dogs passed so far?

In most cases people are not likely to enter their dogs if they don't have a reasonable expectation of qualifying, so poorer dogs will not often be entered. If the quality of the dogs entered is high enough it is conceivable that all could pass. The success of the program cannot be based on how many pass or fail.

4) Is there any difference between a CCA from three Category 1 evaluators versus a dog that obtains the title from a panel that was not all from Category 1?

No. All evaluators are chosen because of their experience and background and a willingness to give a written opinion and scores. At least two of the qualifying scores must come from Category 1 evaluators in order to obtain the title.

5) Why wouldn't GRCA require all CCA evaluators to have bred, exhibited and had success with Golden Retrievers only?

There are certainly knowledgeable and capable people judging Golden Retrievers for the AKC whose primary breed is not ours, and many who come from other Groups as well. They add their wider experience to the pool of evaluators, and there is a place for varying emphasis within the program, just as there is in the show ring. There are also performance people who have a strong dual knowledge of what is required to produce physically good retrievers.

6) How many evaluators are there?

Approximately 4 dozen presently. We initially invited all breeder-judges of Golden Retrievers to apply and more than half of them did. Some people applied through the form posted on the website. A number of versatile breeder-exhibitors are being contacted to expand the Category 2 listing...not all experienced people necessarily want to become AKC judges. In order to make the program viable for hosting clubs a broad geographical listing is desirable.

7) How does the CCA Title add point value to the VC/VCX Program?

Listed below are reasons the CCA adds value and how it could compare to other titles:

Limited tries, a dog can't campaign indefinitely for this title.

Qualified Evaluators with breed experience.

In-depth evaluation of the Golden's conformation not biased towards styles or trends and focused on breed purpose.

Open to all registered or ILP Golden Retrievers over 18 months of age including those which have been spayed or neutered.

No limit to how many dogs can earn this title in a calendar year. Which means if our breeders are breeding more dogs to the standard there is no penalty because of sheer numbers.

Other entry level titles have unlimited tries and can be trained with limited experience and inherited basic instinct.

Many titles that are awarded a high point value in the Versatility titles have no relation to the standard. They require a trained and talented Golden.

Many Golden Retrievers with good to excellent conformation will not be campaigned in the show circuit due to time, money or interest.

If we only scored the field titles based on competitive dog comparisons then none of the WC programs or Hunt Test Programs could count towards a Versatility title because there is no comparative judgment in those events.

Although this is not an official temperament test it is a component of the CCA title.

Experienced breeders and competitors who are not approved AKC judges may qualify and make a difference by becoming CCA Evaluators.

We have put faith in our evaluators, that they award very-good to excellent representatives of the AKC Golden Retriever Standard with a CCA title.

8) Why does the CCA limit attempts to only six evaluations and why can you see such a difference in scores between some of these evaluations?

The primary objective of the CCA Program is to be very rewarding as an educational experience. The goal of the program is to have everyone walk away with respect, admiration for their Golden and a good understanding of the breed standard. Secondly, we put faith in our qualified Evaluators to be objective, educational and reward (with qualifying scores and honorable mentions) good to excellent representatives of the breed in relation to the standard regardless of styles or trends etc. The scores will always differ to varying degrees since the standard leaves room to be subjective. However, the key to managing these differences is to award a dog that is ABLE to obtain three qualifying scores or honorable mentions from the 3 different Evaluators in a limited amount of tries regardless of individual preference or style. The limit was never meant to weaken chances at a title; it was put in place as part of the requirement to earn a CCA Certificate. The requirement being, the dog must receive a qualifying score or honorable mention at a MINIMUM of 50% of its evaluations without the owner/entrant being able to select the Evaluators individually.

9) Can you enter under the same Evaluator twice?

As a participant you will always have the right to choose the CCA Events you wish to enter but the dog must be entered under all the Evaluators on the premium list. A dog may be entered under the same Evaluator twice but only one qualifying score may count towards a CCA certificate. Entering under the same Evaluator could lessen your chances of earning the CCA title if you already have a qualifying score from that individual. However, if a previous score wasn't qualifying there is always a possibility the dog may receive a better score the second time under the same Evaluator. Dogs can look different on a different day.

10) What do I bring to a second event if my dog has qualifying scores from a previous event?

It is a good idea to bring the paperwork showing previous qualifying scores with you. Make sure the CCA Event Secretary is aware of your prior passes when you arrive at the second event or send a note along with your entry form. Also, we would hope and expect people to honor an entrant's word and everything is verified with the CCA Committee before the actual certificates are mailed out.

11) May the host club limit how many dogs an individual owner can enter?

The CCA Committee does not place any restrictions on host clubs regarding limits except that only 1 entry per dog may be accepted. An example of a host club limitation might be: "No owner may have a second dog chosen unless the first dog of all applicants have been accepted." The host club may also choose NO limits or to limit owners to two or three or four dogs in an effort to be fair to all applicants. It is our hope that many future events will meet demand and host clubs will not have to favor limits.
