Puppy Referral

I want to thank everyone for allowing me the privilege to work as your Puppy Referral Representative. Puppy Referral is like a 'Welcome Mat' to all that our club has to offer to prospective new members (puppy buyers). It allows us the opportunity to meet and educate the public while assisting in placing quality, healthy puppies into new homes.

Puppy Referral is a **tool** to help you, as a breeder, find good homes. There are no guarantees that the public will choose to buy a puppy from you simply because you list a litter on our club's website. In other words, it is not the club's responsibility to place a breeder's puppies. There have been questions recently regarding the way litters are listed, the length of time a litter is listed, etc. I would like to clear up a couple of those questions.

#1) When people call me I <u>DO NOT</u> send them to a particular breeder or listing. Instead, I refer them to the website so that they can obtain the information for all of the litters listed at the time. If I have new litter information not yet up on the website, I will give that information to them as well.

#2) Our webmaster places the listings as they come in. They are not listed in any particular order (i.e., date of birth, alphabetically, location, etc) Most puppy buyers look for puppies 'closest to home' first; how they are listed is of little importance.

#3) The club has set a listing time limit of four months from date of birth. However, if a litter has been previously listed, a breeder has a puppy returned for any reason, that puppy is put back on referral at no charge. It may appear that the 'litter' has been listed for an extended period of time.

Over the past several months it became very clear that we needed to address some issues concerning the Puppy Referral program. As a result, our board has decided to make the following listing requirements:

New Puppy Referral Requirements for Mid-Florida Golden Retriever Club

- Must be a regular member in good standing during the previous 12 months
- Puppy referral listing will be limited to 4 months after litter whelp date
- Fee Schedule:
 - If member has attended 2 general club meetings <u>and</u> worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$25.00*
 - If member has not attended 2 general club meetings <u>and</u> has not worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$250.00

*It is the responsibility of the club member to notify the club secretary and the event chairperson to receive credit for these requirements.

Examples of MFGRC sponsored events that qualify for puppy referral:

From the South:

Take the Florida Turnpike North, past the Turkey Lake Service plaza, to **exit 267A**. This is 429 North.

Take 429 North for approx. 10 miles, until it ends at Hwy. 441, near Apopka. Turn **LEFT** onto 441.

Go about 2 miles, to the traffic light at Plymouth Sorrento Road, and turn **RIGHT**.

Go north on Plymouth Sorrento Road, crossing Ponkan and Kelly Park Roads, until Plymouth Sorrento ends at Highway 46. It's about 8 miles to Hwy. 46.

Turn **RIGHT** onto Hwy. 46, go about a half mile to the traffic light, and turn **LEFT** onto 437.

Go about a mile on 437, and turn $\ensuremath{\mathbf{LEFT}}$ onto Wolf Branch Road.





From Tampa:

Drive east on I-4 toward Orlando. You'll want the **second** exit after you pass the exit for Hwy. 27; this is the 429 toll road. On the 429, you'll bypass all the Disney and Orlando traffic.

Take 429 North (a long way), until it ends at Hwy. 441, near Apopka. Turn **LEFT** onto 441.

Go about 2 miles, to the traffic light at Plymouth Sorrento Road, and turn **RIGHT**.

Go north on Plymouth Sorrento Road, crossing Ponkan and Kelly Park Roads, until Plymouth Sorrento ends at Highway 46. It's about 8 miles to Hwy. 46.

Turn **RIGHT** onto Hwy. 46, go about a half mile to the traffic light, and turn **LEFT** onto 437.

Go about a half mile on 437, and turn ${\bf LEFT}$ onto Wolf Branch Road.

From I-4 North of Orlando

Take the exit for the Seminole Mall (#101C), and turn onto Hwy. 46. Take 46 West (toward Mt. Dora) 15 miles to intersection with 437, at a stoplight.

Turn **RIGHT** onto 437.

Go 0.4 of a mile on 437, and then turn **LEFT** onto Wolf Branch Road (there is no right turn here).

Drive 4/10 of a mile, where you'll see a street sign for Equestrian Trail on the **RIGHT** – turn in here. Equestrian Trail is a private road, so it's kind of narrow.




Speaking of which, Mike reports that we collected over 150 samples at the National this year as well as 25 PRA testing samples. As a reminder, blood samples along with pedigrees of the donor dogs are collected and sent to both the BROAD Institute and the CHIC repository with OFA to be kept in storage and used in research for health tests in the future. Also remember that if your dog has donated blood, there will be a notation on OFA when you look them up and it is important to let CHIC know of health issues and the date and reason you lose your dog so the records can be kept updated and the sample can be used in the best possible way.

Thanks, everyone, for all you do to make the GRF such a success!


