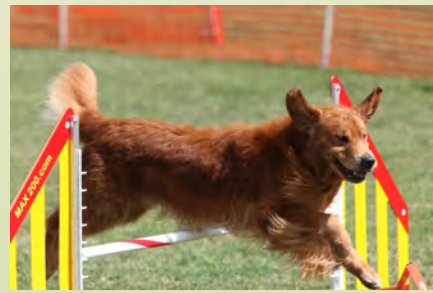

Board Meeting September 2, 2014**

**Board Members Present:** Pat Kopco, Deena Strauss, Leah Wright, Dee Thibodeaux, Tom Young, Deb Farris, Caroline Roetzer, Laura Topping, and Debbie Finch. The meeting was held via telephone conference call and called to order at 7:11 p.m.

**President's Report:** Pat Kopco did not have anything to report.

**Vice President's Report:** Dee Thibodeaux reported that she has no new applications to present.

**Secretary's Report:** Deb Farris made a motion to waive the reading of the minutes of the August Board meeting, seconded by Deena Strauss. All were in favor.

**Treasurer's Report:** Debbie Finch was not available at this point in the meeting, but had previously emailed the Treasurer's Report to the Board. The Obedience Trial posted a profit of \$1,441.74. Our year to date income is \$32,561.12; expenses are \$29,866.65, which yields a net positive for the year to date of \$2,694.47. Current balance in the checking account is \$19,870.11; the money market balance is approximately \$19,800.

**Committee Reports:**

WC/WCX: Discussion was held regarding allowing the FGCGRC to use our guns for the joint WC/WCX at the end of September. Pat Kopco stated that the club's position is we have no issue loaning the guns as long as FGCGRC provides proof of insurance. Deb Farris reported that FGCGRC can assure us that they will have insurance that will cover this.

DOCOF: Deena Strauss reported that the DOCOF fees have been paid for another year.

**New Business:**

AKC Judge Seminar: Pat reported that the AKC rules for judges has changed and that has impacted our hunt test. Two of the judges hired will not be able to judge the test because they have not attended a required second seminar. There are no local seminars available in time for our December test, so Pat has been approached about MFGRC sponsoring a seminar. There is a limit of 25 participants in order for the club to do this. Pat will contact other clubs in Florida and Georgia to see if they are interested in participating.

**Old Business:**

Trailer Storage: Discussion was held regarding our options for storing the agility trailers. Three members have come forward offering their property, and it was agreed that there is one that will be most suitable due to location and ease of moving the trailers when we need them for the agility trial. Pat will contact the member to discuss this and we will make arrangements to move the trailers after the agility trial.

Trailer Contents Insurance: Pat stated that we still need to have a discussion about insurance on the trailers. We will need to determine values on the equipment.

**Next Meeting:**

The next board meeting will be via telephone conference on Tuesday evening, October 7, 2014.

**Adjournment:** Tom Young made a motion to adjourn the meeting, and Deb Farris seconded the motion. The meeting was adjourned at 7:31 p.m.

# Puppy Referral

I want to thank everyone for allowing me the privilege to work as your Puppy Referral Representative. Puppy Referral is like a 'Welcome Mat' to all that our club has to offer to prospective new members (puppy buyers). It allows us the opportunity to meet and educate the public while assisting in placing quality, healthy puppies into new homes.

Puppy Referral is a **tool** to help you, as a breeder, find good homes. There are no guarantees that the public will choose to buy a puppy from you simply because you list a litter on our club's website. In other words, it is not the club's responsibility to place a breeder's puppies. Here are a few FAQs about the puppy referral process:

#1) When people call me I DO NOT send them to a particular breeder or listing. Instead, I refer them to the website so that they can obtain the information for all of the litters listed at the time. If I have new litter information not yet up on the website, I will give that information to them as well.

#2) Our webmaster places the listings as they come in. They are not listed in any particular order (i.e., date of birth, alphabetically, location, etc.) Most puppy buyers look for puppies 'closest to home' first; how they are listed is of little importance.

#3) The club has set a listing time limit of four months from date of birth. However, if a litter has been previously listed, a breeder has a puppy returned for any reason, that puppy is put back on referral at no charge. It may appear that the 'litter' has been listed for an extended period of time.

Over the past several months it became very clear that we needed to address some issues concerning the Puppy Referral program. As a result, our board has decided to make the following listing requirements:

## Puppy Referral Requirements Mid-Florida Golden Retriever Club

- Must be a regular member in good standing during the previous 12 months
- Puppy referral listing will be limited to 4 months after litter whelp date
- Fee Schedule:
  - If member has attended 2 general club meetings and worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$25.00\*
  - If member has not attended 2 general club meetings and has not worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$250.00

\*It is the responsibility of the club member to notify the club secretary and the event chairperson to receive credit for these requirements.

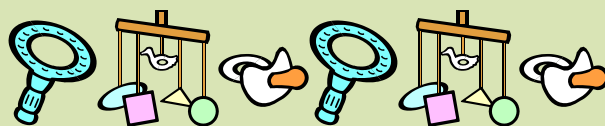

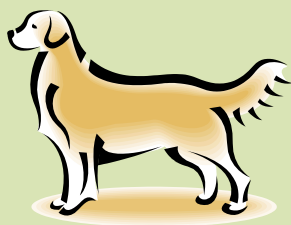
