Board Meeting August 5, 2014**

Board Members Present: Pat Kopco, Mike Orloff, Deena Strauss, Leah Wright, Dee Thibodeaux, Tom Young, Deb Farris, Caroline Roetzer, Laura Topping, Debbie Finch, Sheree Melhuish, and Kristin Sipus. The meeting was held via telephone conference call and called to order at 7:05 p.m.

President's Report: Pat Kopco asked that board correspondence be kept confidential. Pat will be requesting that the chairs of all of our events send the board a monthly report so that the board will be aware of any issues or needs.

Vice President's Report: Dee Thibodeaux reported that she has no new applications to present.

Secretary's Report: Leah Wright had no report.

Treasurer's Report: Debbie Finch presented the treasurer's report. The club does not publish this information on the internet.

Committee Reports:

Agility Trailer Day Clean Out Day: Discussion was held regarding the trailer clean out that took place August 2, 2014. Most of the expense for this were for the truck rental to take the trailers to Camille Doehring's house, but it also included food for the workers and mileage on the trucks. There were six club members present for the clean out. Pat will email Camille and request a list of the equipment that needs to be repaired or replaced and estimated costs.

Obedience Trial: Debbie Finch reported that volunteers are desperately needed for the obedience trial August 9 and 10, 2014. Discussion was held regarding volunteer issues and incentives.

Hunt Tests: Mike Orloff reported that he has all the judges for February. Tom Hell will be finalizing the premium and getting it up on Entry Express soon. Mike will wait until the December test has closed before putting the February one on Entry Express. Discussion was held regarding master entries. Kristin Sipus reported that the Jacksonville club will be holding three master flights. Mike will talk to Wayne Gey, but it was noted that it is very difficult to hold masters on that land. It was agreed that we do not want to limit junior and senior. It is not possible to do more than one master flight in December.

Tracking Test: We still have issues regarding land for the TDX. A lengthy discussion was held regarding the TD/TDX. Pat will send an email to Linda Hitchcock requesting an update on the preparations.

WC/WCX: Deb Farris reported on the WC/WCX to be held September 27, 2014. Kim and Linda Hitchcock are going to be head marshals. Deb reported she will not be using paid throwers if we don't have to, and that she usually gets her volunteers from among people who are entered. Everything else is on track. John and Dee Thibodeaux are the judges. Mike will ensure we have enough birds and has the gunners organized.

Specialty: Caroline Roetzer reported that she has judges and stewards and will begin working on a trophy budget. The entry fees will be the same as last year and will mirror the January circuit of \$28 for the first entry and \$24 for the second. Junior showmanship will be \$14. We will need to begin soliciting for trophy donations and will use a tier program like last year's specialty with the donor names posted ringside and put in the premium list.

Agility Trial: Discussion was held regarding this year's trial. Pat also noted that we may also be needing a chairperson for next year's trial.

New Business:

Storage Fees: Debbie Finch reported that the club is paying approximately \$221 per month for storage of the agility trailers, as well as for storage of some club documents and other items in a 10 x 5 storage unit. These items were previously stored by club members. Pat Kopco suggested that we send out a mass email to the membership asking if anyone has land for storage of the agility trailers. We could perhaps offer an incentive to a member who is willing to do this. Discussion was held regarding issues such as liability and contents insurance, towing the trailers to the agility venue, and possible liability for the person storing the trailers. Pat will email Tom and Joanne to get an idea of what items were moved to the storage unit, and Pat and Mike will go in September and look through what is there to see what can be eliminated.

Trailer Content Insurance: Pat reported that MOC's trailer was recently stolen, along with their brand new equipment. It is our understanding that the trailer contents for the MFGRC agility and hunt test trailers are not insured. The AKC requires an equipment list for the agility trailers, so Pat will request that Camille provide the equipment inventory list. Mike Orloff will work on the equipment inventory for the hunt test trailer. Laura Topping agreed to request a quote. We will also obtain a quote from the insurance company that provides our other insurance coverages for general liability.

Old Business:

Holiday Party: Caroline Roetzer reported that Dee Thibodeaux has offered her home for the holiday party on Saturday, December 13, 2014. She is located near Ann Rowe in Sorrento. Time and other details will be determined later.

Raffle Basket for National Specialty: Discussion was held regarding donating a basket for the raffle. Laura Topping offered to put together a basket. Debbie noted that in 2011 the board had allocated \$180 toward a basket for the national, according to the club records. Motion was made by Debbie Finch and seconded by Kristin Sipus to authorize Laura to spend a maximum of \$200 for items for the basket, and the motion was carried unanimously.

Nominating Committee: Tom Young reported that he needs to hear from the current board members on who will be returning to the board next year. The President, Vice President and Treasurer positions are filled. A volunteer will be needed to serve as Secretary, and there are two members interested in serving on the board. Discussion was held regarding next year's board meetings and that will be a consideration for those on the west coast. Pat asked everyone to send Tom an email with this information. Leah will send out a mass email asking club members to contact Tom Young if they are interested in serving on the board or as the secretary.

Next Meeting:

The next board meeting will be via telephone conference on Tuesday evening, September 2, 2014.

Adjournment: Mike Orloff made a motion to adjourn the meeting, and Dee Thibodeaux seconded the motion. The meeting was adjourned at 8:56 p.m.

Committee Reports:

Hunt Tests: Pat reported that the December and February hunt tests are on track. As always, volunteers are needed in all venues.

Agility Trial: Pat reported that this event is on track. For next year, we will probably be at a new property and will probably have a new chairperson. We attempted to change venues this year, but we had a judging issue and we had to honor our contract with him which did not allow us to move it to the other venue. The trial will be held at Bill Frederick Turkey Lake Park in October.

WC/WCX: Pat reported that this event is on track. This event will be held by MFGRC on Saturday and the Florida Gulf Coast club on Sunday.

Tracking Test: The club will be holding a tracking test in February. However, we will be unable to hold a TDX due to land issues and this will be replaced with the Tracking Dog Urban test (TDU). We attempted to do this last year and received complaints from several members. After attempting to rectify the situation, the board felt it had no other choice because the land is just not available in the Central Florida area to hold the TDX.

Specialty: Our specialty will be held on Friday, December 12, 2014, in conjunction with the Eukanuba. We will be called on again to do Meet the Breeds at Eukanuba. Please contact Pat Kopco if you are interested in working a half day either of the two days that weekend to talk to people about goldens. Tickets will be given to those members who participate and work at least a half day either day.

Old Business:

There was no old business to discuss.

New Business:

Holiday Party: Dee Thibodeaux has offered the use of her home for the holiday party. The party will be held on Saturday, December 13, 2014, at a time to be determined. Dee's home is located in Sorrento, and a map and more details will be provided as the time draws near.



Puppy Referral

I want to thank everyone for allowing me the privilege to work as your Puppy Referral Representative. Puppy Referral is like a 'Welcome Mat' to all that our club has to offer to prospective new members (puppy buyers). It allows us the opportunity to meet and educate the public while assisting in placing quality, healthy puppies into new homes.

Puppy Referral is a **tool** to help you, as a breeder, find good homes. There are no guarantees that the public will choose to buy a puppy from you simply because you list a litter on our club's website. In other words, it is not the club's responsibility to place a breeder's puppies. Here are a few FAQs about the puppy referral process:

#1) When people call me I DO NOT send them to a particular breeder or listing. Instead, I refer them to the website so that they can obtain the information for all of the litters listed at the time. If I have new litter information not yet up on the website, I will give that information to them as well.

#2) Our webmaster places the listings as they come in. They are not listed in any particular order (i.e., date of birth, alphabetically, location, etc.) Most puppy buyers look for puppies 'closest to home' first; how they are listed is of little importance.

#3) The club has set a listing time limit of four months from date of birth. However, if a litter has been previously listed, a breeder has a puppy returned for any reason, that puppy is put back on referral at no charge. It may appear that the 'litter' has been listed for an extended period of time.

Over the past several months it became very clear that we needed to address some issues concerning the Puppy Referral program. As a result, our board has decided to make the following listing requirements:

Puppy Referral Requirements Mid-Florida Golden Retriever Club

- Must be a regular member in good standing during the previous 12 months
- Puppy referral listing will be limited to 4 months after litter whelp date
- Fee Schedule:
 - If member has attended 2 general club meetings and worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$25.00*
 - If member has not attended 2 general club meetings and has not worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$250.00

*It is the responsibility of the club member to notify the club secretary and the event chairperson to receive credit for these requirements.
