GOLDEN TALES APRIL 2012

Board Members present: Camille Doehring – Joanne Hell – Tom Hell – Leah Wright – Judi Volpe – Jill Wallace – Tammy Hodgkins – Deena Strauss – Shirl Phillips - Debbie Finch

Meeting was called to order by President Camille Doehring at 10:21 AM.

Outgoing Vice President Debbie Finch presented two new member applications: Jill Berke, who has attended two meetings (sponsored by Maura Roxby), and Barbara Anderson (sponsored by Ann Rowe). Vote was unanimous to accept these applications. Debbie handed over blank applications to 2012 VP Joanne Hell.

There was no Secretary's report due to the December Minutes having already been sent out to the Board and the newsletter. Motion to waive reading of those minutes was made by Joanne Hell, and seconded by Leah Wright.

Tom Hell presented the Treasurer's report for the month of December 2011: (We do not publish income information on the internet). Tom presented a trend analysis of cash on hand at year end for the period of 2007 through 2011, as well as total entries for all club-sponsored events for the same period. It was quite clear that the decline in the year-end cash on hand total is directly related to the overall decline in total entries. The Board agreed to keep a close eye on expenses in 2012, and to try to be conservative with expenses.

Committee Reports:

February Hunt Test: Tom Hell will coordinate with HT Chair Mike Orloff to address acquisition of ducks. Tom reported that our usual source for ducks contacted him to advise that the price of ducks has sharply increased, to \$16 each. We discussed the possibility of increasing entry fees at future hunt tests, particularly for the Master test, which uses more ducks than Junior or Senior. Shirl, Tammy and Judi are working on the dedication to Susan Fulenwider for the catalog.

February Tracking Test: Debbie reported that she has talked to Test Secretary Joyce Swegle. Joyce is working on the catalog for the test, and other than needing volunteers to lay tracks, everything has been taken care of.

Agility Trial: Tom reported that we are looking into rubberizing the contacts on the club's equipment, expecting that the AKC will require this in the not too distant future. Tom has been in touch with Robin and Denny Scott, and Denny is working up cost numbers for us. Tom and Debbie explained that this is a very expensive new process, and that most clubs which host agility trials are having done. Tom said he is certain that Denny will be able to do this for far less cost than if we contract with a commercial vendor to rubberize our equipment. We all agreed that we will go with purple as the color, in order to use the leftover material that Denny has on hand, saving us even more money. Debbie reported that she has seen Robin's equipment with the rubberizing in purple, and it looks really good. We also discussed possible alternate locations, including the TG Lee site. Camille will consult with Agility Chair John Blair on this.

Old Business

Field Dog of the Year Perpetual Trophy: Joanne will order from DannyQuest. We all agreed on the golden flushing a pheasant as our preferred design.

Eastern Regional: Camille reported on the site visit and discussion with the host hotel. Camille said the host hotel is very motivated to work with us, is ideally located, and is willing to provide a block of two-room suites for a very good price. Tom and Camille are reviewing the prospective contract with the hotel. Tammy will do an ad for the *GR News*; we discussed in which issues to run the ad, which will include an RSVP page for ordering merchandise. Leah is going to set up a Facebook page for the Regional. Camille is going to ask Sheree Melhuish if she will put together hospitality bags. We discussed merchandising, and agreed for now on insulated mugs similar to what was sold at the 2011 GRCA National Specialty, as well as various styles of shirts. Joanne will research and provide more details on merchandise options.

Rescue Reunion: Debbie reported that she has confirmed that this year's Reunion will be the same day as our Eye Clinic at the Strawberry Cluster in February. Debbie has advised GRRMF that MFGRC will not be able to provide groomers at this year's Reunion.

DACOF: Debbie reported that she has a link to a Yahoo group website for communication about DACOF, and Leah said she would try to set us up to get our foot in the door to enter a team.

Heart and Eye Clinics: will be held on February 18th and 19th. Camille has obtained doctors for both days. Leah will send out a mass e-mail asking for volunteers to help staff each clinic.

New Business:

MFGRC website: all agreed that we would like to modify the website to make it more user friendly, and more "dynamic." Tom will set up a meeting with webmaster Diane Hosenbold to discuss possible changes. Camille suggested that the Board members Google other GR clubs for ideas to provide to Diane.

GR News Member Report: due to confusion over who was actually going to write the report, there has been no MFGRC submission in the last couple of issues. Camille is going to talk to a member who had volunteered to write the report at one point, and ask Sheree if she is still willing.

Tom reported that the local Flatcoat Retriever club (specifically Pam Hind and Beth Meany) has asked to borrow some of our hunt test equipment for their upcoming WC/WCX test, which will be held at Wayne Gey's ranch. Discussion ensued, and we agreed, since we know Beth and Pam, and since some of our Board members will be present at the test, that we have no problem loaning our equipment, except for guns. Debbie made a motion to loan out our equipment, except for the guns, and Tom seconded the motion. Vote was unanimous.

January 22, 2012

Call to order

President Camille Doehring called the regular meeting of the Mid-Florida Golden Retriever Club to order at 1:20 PM on January 22, 2012, at the home of Tom and Joanne Hell in Lakeland, Florida. Camille announced that the sign-in list is circulating and asked everyone to be sure to place a checkmark by their name.

Vice President's Report

VP Joanne Hell reported two new members: Jill Berke, who has attended two meetings and was voted in as a full member, and Barbara Anderson, who is now an associate member because she has not yet attended a meeting.

Treasurer's Report

Treasurer Tom Hell presented the Treasurer's report. (We do not publish income information on the internet.) Tom reminded current members if they haven't paid dues yet for 2012 to give him a check.

Secretary's Report

No Secretary's report from the December meeting – minutes will be published in the newsletter. Tom Hell motioned to waive the reading of the minutes, and Jerrie Morrison seconded.

Committee Reports

Camille announced that a group will meet at Wayne Gey's Golden Oaks ranch on January 29 at 10AM to clean out the hunt test trailer, in preparation for the upcoming Spring Hunt Test. Helpers are welcome.

Tom Hell briefly discussed the upcoming Hunt Test on Feb. 11th & 12th in Montverde, and asked volunteers to contact Chair Mike Orloff if willing to help with all the chores that are necessary to put on a successful test. Closing date for entries is Jan 30th.

Camille provided an update on the Eastern Regional we are hosting in October, and provided the dates of each event. Caroline Roetzer is the Chairperson for both the Everglades (10/26/2012) and Mid-Florida (10/27) individual Specialties. Shirl Phillips is the Chair for the GRCA Specialty on 10/28/2012. We will hold a WC/WCX on Oct. 24th, and a CCA on the 25th. There will be a hospitality room on Friday, and we are planning a banquet for Saturday night. Camille discussed the upcoming heart and eye clinics to be held on February 18th + 19th, in conjunction with the Strawberry Cluster in Lakeland. Camille is looking for volunteers to help staff the clinics. We plan to hold the February general meeting midday on Saturday when the vet takes a lunch break.

Camille also asked members to check out our website, and provide any ideas they may have to update the look of our site. Please send an e-mail to any Board member with suggestions.

New Business

Jerrie Morrison suggested we plan to hold a tracking seminar to introduce members to this activity.

Camille expressed special thanks to Ray Caito for all of his efforts in working with the puppies at today's fun field day event. Camille also thanked Tom and Joanne Hell for hosting today's gathering.

Camille discussed upcoming events: March 9th is the Everglades Specialty; March 11th is the Flatcoat Retriever club's WC/WCX; March 24th is our club's Match at Ann Rowe's – judges were announced, and Ann said that we will most likely have barbecue for lunch. Camille also announced that the April meeting will be held on the 22nd, and will be a fun agility at Robin Scott's home in Eustis. Debbie suggested that we ask Robin and Denny if we could grill hamburgers and hot dogs, and ask members to bring a dish to share.

Secretary's report: Minutes will be published in the newsletter. Motion to waive reading of the minutes was made by Judi Volpe, and seconded by Joanne Hell.

Tom Hell had no Treasurer's report tonight.

Committee Reports:

February Hunt Test: Tom Hell reported that he and Mike Orloff are working to acquire additional ducks due to the large entry. Tom related that it has gotten more difficult to find a supplier, plus prices have increased sharply. Tom reported that we usually spend around \$3000 for ducks for the February Hunt Test, but he expects that it will cost us approx. \$7400 this time – more than double the previous cost. The entries are currently at 311 dogs. Tom is going to ask the Central Florida hunting club if we can borrow some of their equipment since we will need to have a third Master flight due to the large entry. He is also going to buy more ammunition and poppers. We have marshals for every stake. Tom discussed the plan for location of the stakes. Char-Don will cater the tailgate party on Saturday night. Tammy is doing the running order sheets.

February Tracking Test: Camille reported that all is ready for this weekend's test.

Eastern Regional: Camille reported that the hotel contract has been signed. Reservations can be made in March. We reviewed the verbiage for the ad for *GR News*. Joanne reported on the search for mugs to sell as merchandise at the Regional. Shirl reported that we will be able to get pens from the HeartGard representative. We want to set up a special page on the website, and have a banner or highlight on the main page with a link to the dedicated page. We want to try to find a vendor for 3x5 memo pads with the Regional logo to put in the hospitality bags. Camille has been trying to reach Sheree Melhuish to ask if she will put together hospitality bags.

Old Business

DACOF: No update on DACOF.

Heart and Eye Clinics: Camille reported that we have 23 eye entries at this point, and just a few entries for the heart clinic. Judi will work up a volunteer schedule.

MFGRC website: Camille suggested that since February is so busy, we will attempt to schedule a get together with webmaster Diane when things calm down in March. We want to try to meet somewhere that has WiFi to enable us to see options in real time.

New Business:

July meeting: Joanne suggested that we hold a problem solving "class" with Nancy Withers instructing / leading. We discussed options for doing a one or two day seminar. Joanne will check with Nancy to inquire about her preferences.

Shirl discussed the Golden Retriever Lifetime Study she has just learned about, and passed around brochures. Shirl knows the lead doctor in the study, from her previous experience with the vets at Cornell University.

The Board meeting was adjourned at 9:20PM. Motion to adjourn was made by Judi Volpe, and seconded by Shirl Phillips.

Secretary's report: Minutes will be published in the newsletter. Motion to waive reading of the minutes was made by Joanne Hell, and seconded by Deena Strauss. Debbie also reported that she has received letters from the AKC advising that both days of the (February) Hunt Test, and the TD/TDX Tracking Test, have been closed out.

Tom Hell presented the Treasurer's report for the month of February 2012: (In the interest of the club, we do not publish income information on the internet). On the heart and eye clinics, Camille and Tom reported that in terms of the number of examinations performed (51 eye exams, 35 heart exams), this was the largest clinic MFGRC has put on.

Tom also presented a box that the Club has received from the National Breast Cancer Foundation, as a thank you for our fund-raising support the last six years. The box includes a handwritten thank you note, an engraved plaque, pink lanyards, pink tennis balls, and dog toys. We decided to display the contents at the upcoming Match, and we will make an announcement during the meeting.

Tom also announced that because we had loaned our hunt test equipment to the Flat Coat Retriever Club for their WC/WCX, the Flat Coat club has made a \$50 donation to the Golden Retriever Foundation on behalf of MFGRC.

Committee Reports:

Match (March 24, 2012): Leah reported that we have a few pre-entries. Camille has communicated with Ann Rowe, who reports that everything is covered.

Agility Trial (October 13-14, 2012): Camille reported that she has heard from Chair John Blair. John has submitted the entry fee change to the AKC. John has contacted Kirby Rentals about tents and tables. The club-owned agility equipment is currently in the process of being rubberized.

Eastern Regional (October 24-28, 2012): Camille suggested that a Committee meeting be held after the general meeting at the Match on March 24th, in part to start working on the premium list, and also to touch on the status of planning for everything. We're glad you're here!

I want to thank everyone for allowing me the privilege to work as your Puppy Referral Representative. Puppy Referral is like a 'Welcome Mat' to all that our club has to offer to prospective new members (puppy buyers). It allows us the opportunity to meet and educate the public while assisting in placing quality, healthy puppies into new homes.

Puppy Referral is a **tool** to help you, as a breeder, find good homes. There are no guarantees that the public will choose to buy a puppy from you simply because you list a litter on our club's website. In other words, it is not the club's responsibility to place a breeder's puppies. There have been questions recently regarding the way litters are listed, the length of time a litter is listed, etc. I would like to clear up a couple of those questions.

#1) When people call me I DO NOT send them to a particular breeder or listing. Instead, I refer them to the website so that they can obtain the information for all of the litters listed at the time. If I have new litter information not yet up on the website, I will give that information to them as well.

#2) Our webmaster places the listings as they come in. They are not listed in any particular order (i.e., date of birth, alphabetically, location, etc) Most puppy buyers look for puppies 'closest to home' first; how they are listed is of little importance.

#3) The club has set a listing time limit of four months from date of birth. However, if a litter has been previously listed, a breeder has a puppy returned for any reason, that puppy is put back on referral at no charge. It may appear that the 'litter' has been listed for an extended period of time.

Over the past several months it became very clear that we needed to address some issues concerning the Puppy Referral program. As a result, our board has decided to make the following listing requirements:

**New Puppy Referral Requirements
for
Mid-Florida Golden Retriever Club**

- Must be a regular member in good standing during the previous 12 months
- Puppy referral listing will be limited to 4 months after litter whelp date
- Fee Schedule:
 - If member has attended 2 general club meetings and worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$25.00*
 - If member has not attended 2 general club meetings and has not worked at 1 MFGRC sponsored event during the previous 12 months the fee is \$250.00

*It is the responsibility of the club member to notify the club secretary and the event chairperson to receive credit for these requirements.
