Baby Puppy 3-6 Months
Junior Puppy 6-9 Months
Senior Puppy 9-12 Months
Junior Dog.....12-18 Months
Adult Dog.....18 Months to 7 years
Veterans.....7 years and up

OBEDIENCE CLASSES

Regular - Beginner Novice, Novice, Open and Utility
Non-Regular - Veterans 7 Years and Up

RALLY CLASSES - Novice, Intermediate, Advanced, Excellent and Master

You may enter any class for practice only (mark PO). Dogs entered for "PO" are not eligible for prizes. AKC regulations apply.

JUNIOR SHOWMANSHIP – Novice Jr., Intermediate Jr., Open Jr., Novice Sr., Intermediate Sr., Open Sr. Jr. Showmanship is divided into Jr. 8-12 & Sr. 13-17 Novices have not yet earned 3 Novice wins at AKC licensed shows.

SITE DIRECTIONS (address is 23840 Oak Valley Lane, Sorrento, FL 32776):

From the South:

Take the Florida Turnpike North past the Turkey Lake Service Plaza. Follow sign for Apopka 429. Stay on 429 and follow the signs to Mount Dora and Kelly Park Road. Right on Kelly Park Road then go left on Plymouth Sorrento until the road ends at Hwy 46. Turn right on Hwy 46 and at the next light go Left Hwy 437. At the next light take a Left onto Wolf Branch Road. Go 4/10 of a mile and take a Right onto Equestrian Trail. The next left is Oak Valley and Ann's driveway is on the Left. You can also pick up the 429 off of I-4 just past Hwy 27.

From I-4 North of Orlando:

Take exit 101B-A toward CR-46A/SR-417-TOLL/Int'l Airports/Sanford/West Beltway/Mount Dora onto SR-429-TOLL S (Wekiva Pkwy). Go for 10.9 mi. Take exit 44 toward SR-46/CR-46A/Sorrento/Mt Plymouth. Go for .4 mi. Continue on SR 46 (SR-46W) toward CR-46-A W. Go for .6 mi. Turn left onto Sorrento Ave (SR-46). Go for 2.0 mi. Turn right onto Plymouth Sorrento Rd (CR-437 N). Go for .5 mi. Turn left onto Wolf Branch Road. Go for .5 mi. Turn right onto Equestrian Trail (street sign will be on the right – this is a narrow private road). Go for .4 mi. Turn left onto Oak Valley Lane. Go for .2 mi. Site will be on left.

From Tampa/Lakeland:

Drive east on I-4 toward Orlando. You'll want the second exit after you pass the exit for Hwy. 27; this is the 429 toll road. Follow sign for Apopka 429. Stay on 429 and follow the signs to Mount Dora and Kelly Park Road. Right on Kelly Park Road then go left on Plymouth Sorrento until the road ends at Hwy 46. Turn right on Hwy 46 and at the next light go Left Hwy 437. At the next light take a Left onto Wolf Branch Road. Go 4/10 of a mile and take a Right onto Equestrian Trail. The next left is Oak Valley and Ann's driveway is on the Left. You can also pick up the 429 off of I-4 just past Hwy 27.
