

# General Meeting Minutes July 16, 2024

## **Board Reports:**

**President – Robin Burket** called the meeting to order at 7:04 p.m. commenting on the success of the July 6<sup>th</sup> Specialty at WEC

**Secretary – Cindy Patz** - asked if there were any comments or change requests to the June General Meeting Minutes as posted on the website.
