

# Board Meeting Minutes March 4<sup>th</sup>, 2025

## Reports:

President – Robin Burket opened the meeting at 6:02 pm

**Secretary** – Cindy Patz called for a motion to approve the February Board Minutes as posted; Robin Bowen made a motion to approve the minutes as posted, Robin Burket seconded the motion, and it passed unopposed. Cindy also reported that the membership Survey email blast has been requested.

### Committee Reports:
